Direction:

La Veta is located in Huerfano County in Southern Colorado... south of Denver (3 hours), Colorado Springs and Pueblo and north of Trinidad. From points north drive south on I-25, from New Mexico drive north on I-25, and exit west at the town of Walsenburg. Drive west on highway 160 for 10 miles to Highway 12 (turn left). Drive south for a beautiful five miles to La Veta located at the base of the Spanish Peaks Mountains. You will pass the airport and descend into the town of La Veta. Cross the railroad tracks and turn right on Ryus Avenue. The SPACe Gallery is on your right, in the park, across the street from the bakery.
